NO.GP-04 -AYS-2020 -SFS-137 -CHH:- In exercise of the powers conferred by sub-section (1) of section 20 read with section 4 of the Gujarat Professional Medical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj.3 of 2008), the Government of Gujarat hereby makes the following rules further to amend the Gujarat Professional Post-graduate Ayurved and Homoeopathy Medical Educational Courses (Regulation of Admission) Rules, 2018, namely:-

1. (1) These rules may be called the Gujarat Professional Post-graduate Ayurved and Homoeopathy Medical Educational Courses (Regulation of Admission) (Amendment) Rules, 2021.  
(2) They shall come into force on and from the date of its publication in the *Official Gazette*.
2. In the Gujarat Professional Post-graduate Ayurved and Homoeopathy Medical Education Courses (Regulation of Admission) Rules, 2018 ( hereinafter referred to as the "said rules"), in rule 2, in sub-rule (1), -
  - (a) in clause (d), for the word ' Ayurved', the word 'Ayurvedic' shall be substituted;
  - (b) in clause (h), for the word ' Ayurved', the word 'Ayurvedic' shall be substituted.
3. In the said rules, in rule 3, in sub-rule (1), -
  - (a) for para A under the heading "Government Seats" the following para shall be substituted, namely: -

**"A. Government Seats, -**

    - (i)(a) All the sanctioned seats of the Professional Post-graduate Ayurved and Homoeopathy Medical Educational Courses in the Government and Grant-in-aid Colleges or Institutions of the State excluding fifteen per cent. (15 %) seats of All India Quota in the MD/MS Ayurved and MD Homoeopathy Courses; and
    - (b) All the sanctioned seats of Institute of Post-graduate Teaching and Research in Ayurveda (I. P. G. T. and R. A), Jamnagar, excluding fifty per cent. (50 %) Seats of All India Quota in the MD/MS Ayurved Courses;
    - (ii) Sixty per cent. of total sanctioned seats of the Professional Post-graduate Ayurved and Homoeopathy Medical Educational Courses in the unaided Colleges or Institutions excluding fifteen per cent (15%) seats of All India Quota and Twenty-five per cent (25%) management seats as provided in para B in the MD/MS Ayurved Courses and MD Homoeopathy Courses:



Provided that management seats including Fifteen per cent. Non-Resident Indian seats in MD/MS Ayurved Courses and MD Homoeopathy Courses shall be filled by consortium.”;

(b) after para C, the following para shall be inserted, namely: -

**“D. All India quota Seats, -**

- (i) fifteen per cent. (15%) seats of all sanctioned seats of Government, Grant- in- aid and Unaided institutes; and fifty per cent. (50%) seats of I.P.G.T. & RA, Jamnagar shall be reserved for All India quota seats;
- (ii) All India Quota Seats shall be filled in by the authority designated by the Central Government:

Provided that after filling of seats under this para if any All India Quota Seats remains vacant such seats shall be filled in as per provisions of para (A) of Government seats;

4. In the said rules, in rule 4,

(a) for sub-rule (2), the following sub-rule, shall be substituted, namely: -

“2. The candidate seeking admission in MD/MS Ayurved courses must have completed final year BAMS, from University established under any law of state of Gujarat and recognised by competent statutory authority and have completed compulsory rotating internship on or before the 30th September of current academic year:

Provided that a candidate who desires admission on All India Quota seats of unaided institute of Gujarat State shall have completed his BAMS from Institution situated in the State of Gujarat or anywhere from India and have qualified in AIA-PGET of respective academic year as per the criteria laid down by the competent authority.”;

(b) For sub-rule (3), the following sub-rule shall be substituted, namely: -

“3. The candidate seeking admission in MD Homoeopathy courses must have completed final year BHMS or Graded BHMS, recognised/permitted course from the University established under any law of the Government of Gujarat and completed compulsory rotating internship on or before the 30th September of current academic year:

Provided that a candidate who desires admission on All India Quota seats of unaided institute of the Gujarat State shall have completed his BHMS from Institution situated in the state of Gujarat or anywhere from India and have qualified in AIA-PGET of respective academic year as per the criteria laid down by the competent authority.”;

(c) sub-rule (4) shall be deleted;

(d) for sub-rule (5), the following sub-rule shall be substituted as under, namely: -

“5. A candidate who has secured admission under these rules in any year shall also be eligible for admission to MD/MS Ayurved or MD Homoeopathy courses subject to payment of total fees as determined by the Fee Regulatory Committee for entire course which he is pursuing currently and thereupon the concern institute shall be required to issue the “No Objection Certificate” and return original documents. The candidate shall be required to submit the same to the Admission Committee during the registration process for considering his eligibility for new admission.”;

(e) in sub-rule (6),

(i) in para for (A), for the heading, “**For Government Seats**”, the heading “**For Government Seats and Management Seats**” shall be substituted;



(ii) para (B), shall be deleted.

5. In the said rules, in rule 5, -

(a) in clause (A), sub-clause (1), shall be deleted;

(b) in clause (A), for sub-clause (2) the following sub-clause shall be substituted, namely: -

“(2) After deduction of the All India Quota, Management Quota along with NRI Quota Seats from total number of available seats, remaining seats shall be reserved for the candidates of the Gujarat origin and falling under the following categories, to the extent of percentage shown against it: -

(a) Scheduled Castes (SC): 7%

(b) Scheduled Tribes (ST): 15%

(c) Socially and Educationally Backward Classes (SEBC): 27%

(d) Economically Weaker Sections(EWS): 10 %

For Allocation of seats (SC/ST/SEBC/OPEN/EWS and Person with Disability (PwD)), under different categories, a roster system as notified by the State Government shall be followed. The roster register shall be maintained at the State level for all the courses and categories and used for allocation of seats as per roster register:

Provided that All India quota seats shall be reserved for different categories as per the guidelines of ministry of AYUSH.

**Explanation** - The reservation of the seats shall be for the candidates belonging to the Scheduled Castes, Scheduled Tribes, Socially and Educationally Backward Classes and Economically Weaker Sections(EWS) recognised as such in the State of Gujarat and not for those who have migrated from other States.

6. In the said rules, in rule 6,

(a) in the title for the words “Reservation of Disabled person”, the words “Reservation for Person with Disabilities” shall be substituted;

(b) the following proviso shall be added, namely:-

“Provided that if any seat/seats remain vacant in the category of Person with Disabilities, it shall be converted and filled in by respective category during respective online/offline admission round from the candidates available in the Merit list published by the Admission Committee”.

7. In the said rules, in rule 7, -

(a) for clause (i), the following clause shall be substituted, namely: -

“(i) State Government shall constitute Admission Committees to conduct, supervise and control the entire process of admission of students to Government seats to the Professional Post-graduate Ayurved and Homoeopathy Medical Educational Courses. Admission to all seats shall be conducted by centralized single window state counseling by the Admission Committee to make it a one composite process;

(b) In clause (iii), for the word “off-line”, the words “off-line/online” shall be substituted;

(c) after clause (iv), the following provisos shall be added, namely: -

“Provided that management seat including NRI seats in MD/MS Ayurved Courses and MD Homoeopathy Courses shall be filled by the Consortium for each course. The Consortium shall, by an advertisement in two English and two Gujarati leading newspapers widely circulated in the State, shall invite an application from the eligible candidates for the admission to the MD/MS Ayurved Courses



and MD Homoeopathy Courses on the management seats. The advertisement shall contain the date of issue of application forms, centers for availing application forms and submitting the same, last date for submission of application forms, details of fees to be paid and eligibility criteria and numbers of seats available for admission on the Management seats and such other information as may be necessary in this behalf:

Provided further that the Consortium shall also make necessary arrangements to issue and receive the application forms for admission to the Management seats at the office of the Admission Committee at the GMERS Medical College, Gandhinagar:

Provided also that all the Management seats shall be filled in by the Consortium by a Single Window System on the basis of merit list prepared on the basis of All India Overall rank of the candidates and whose names appear in the merit list prepared by the Admission Committee in presence of officer/s designated/appointed by the Admission Committee or concerned Authority:

Provided also that no candidate shall be admitted against the Management seats unless his name appears in the merit list prepared by the Admission Committee:

Provided also that where any Non-Resident Indian seat remains vacant, such seats shall be converted into Management seats and filled in from the merit list of management seats.”; and if Management seats remain vacant shall be filled as per rule 7 (i):

Provided also that All India Quota seats of unaided institute of Gujarat state shall be filled in by separate merit list under the criteria laid down by Central Government as per the notification of central government time to time.”

8. In the said rules, in rule 8, -

(a) in clause (iii), for the word “off-line”, the words “off-line/online” shall be substituted;

(b) In clause (v), the word “off-line” shall be deleted;

(c) for clause (vi), the following clause shall be substituted, namely: -

“(vi) The receipt/ confirmation can be obtained for the application and the applicant shall be given the registration number and date of his application in the receipt and the same shall be used as reference in all future correspondence and also used in the merit list.”;

(d) after clause (vi), the following clause shall be added, namely: -

“(vii) In case of minimum qualifying percentile of AIA-PGET revised by the Government of India, Ministry of AYUSH, New Delhi, fresh application shall be invited from the desirous candidates who have become eligible as per the revised AIA-PGET percentile and their names shall be included as per overall All India rank allotted to the candidates by concerned agency/body and revised merit list shall be published by the Admission Committee. Such candidates shall be eligible for the admission in available seats for subsequent rounds/Mop up round of Counseling.”

9. In the said rules, in rule 9, in sub-rule (1), -

(a) for clause (i), the following clause shall be substituted, namely: -

“(i) BAMS/BHMS mark-sheets of all years”;

(b) for clause (ii), the following clause shall be substituted, namely: -

“(ii) AIA-PGET mark sheet of the current academic year”;

(c) for clause (iii), the following clause shall be substituted, namely: -

“(iii) Eight-month internship completion certificate for those candidates who have passed their BAMS/BHMS in current academic year. Twelve-month completion in case of



candidates who have passed BAMS/BHMS before current academic year”;

(d) for clause (vi), the following clause shall be substituted, namely: -

“(vi) Caste certificate for a candidate belonging to Scheduled Castes (SC), Scheduled Tribes (ST), Socially and Educationally Backward Classes (SEBC) and Economically Weaker Sections (EWS) issued by the authority empowered by the Government in this behalf (for SC, ST, SEBC and EWS candidates):

Provided that candidate seeking admission on reserved seats of All India quota seats of unaided institutes of Gujarat shall be required to produce a certificate of caste issued by the competent authority of his respective State from which he originates”;

(e) in clause (vii), the following proviso shall be inserted, namely:

“Provided that candidate seeking admission as SEBC (OBC) candidate for All India Quota seats of unaided institutes of Gujarat shall submit Non-Creamy Layer certificate issued by the competent authority of his respective State as per prevailing policy of the respective State Government”.

10. In the said rules, in rule 10, -

(a) for the para under heading “Preparation of Merit List for admission”, the following para shall be substituted namely: -

“The merit list of the candidates, who have applied for admission, in the prescribed form, within the prescribed time limit and who are found eligible in AIA-PGET for admission under these rules shall be prepared in the following manner, namely: -”;

(b) for sub-rule (1), the following sub-rule shall be substituted, namely: -

“(1) Merit list shall be prepared on the basis of All India Overall rank of the candidates who found eligible in AIA-PGET of current academic year”;

(b) sub-rules (5) and (6) shall be deleted.

11. In the said rules, in rule 11, in sub-rule (1) for the words “off-line” wherever it occurs, the words “off-line/online” shall be substituted.
