

## ADMISSION ELIGIBILITY

### Available Seats

Seats available for admission process are known as :

- **Government Seats (process done by ACPC)**
  - I. All the sanctioned seats of the Engineering and Technology Courses in the Government Colleges or Institutions of the State,
  - II. All the sanctioned seats of the Engineering and Technology Courses in the aided Colleges or Institutions,
  - III. Fifty percent. of the total sanctioned seats of the Engineering and Technology Courses in the unaided Colleges or Institutions, and
  - IV. All supernumerary seats of the professional courses in the Government Colleges or Institutions and in the aided and unaided Colleges or Institutions.
- **Management Seats (process done by Institute(unaided))**
  - I. Fifty percent seats of the total sanctioned seats of the Engineering and Technology courses in the unaided Colleges or Institutions including 15 per cent of NRI seats.
  - II. The intimation received, in respect of sanction of seats, by the Admission Committee three days prior to the counselling program, shall be considered as available seats:

Provided that the Government Seats shall be available for online admission for two rounds by the Admission Committee:

Provided further that the registration and preparation of merit list of the Management Seats shall be managed, finalized and declared by the concerned college or institution.

### Admission Eligibility for Government Seats

**[A] For Students who have passed qualifying examination from school located in Gujarat and appeared in GUJCET -2020**

A candidate shall have passed HSC (10+2) with minimum 45% marks (40% for SC/ST/SEBC/EWS) of theory (or theory and practical) marks of Physics & Mathematics as compulsory subjects with (Chemistry or Biology or Technical Vocational subject) from a single board. Candidate shall also appear in GUJCET -2020 examination in respective subjects. The candidate shall pass the HSC examination **from schools located in Gujarat from any board from GSEB, CBSE, ISCE, Cambridge, International Baccalaureate (IB) or NIOS.**

or

**A candidate whose parents are of Gujarat origin** and who has passed the qualifying examination with minimum eligibility criteria of percentage of marks in subjects prescribed by AICTE from time to time from the State where his parents are located and has appeared in the GUJCET conducted in the corresponding academic year, shall be eligible for admission.

or

**A candidate whose parents are serving in the category of services** as mentioned in admission rules and who are transferred from other States to Gujarat and have resumed their duties in the place where they are transferred in Gujarat and shall remain so transferred in the State of Gujarat at the time of registration for admission, shall be eligible for admission and his candidature shall be included in the merit list.

or

**A candidate who has studied under Jawahar Navodaya Vidyalaya Scheme / Sainik School** up to Standard VIII in any of the schools located in the State of Gujarat, and there after studied in any of the schools located out of the State of Gujarat under the said scheme, and passed Qualifying Examination from a Navodaya Vidyalay / Sainik School located outside Gujarat State.

# Admission Process for ME/MTech/MPharm courses

The Online Admission Process carried out by ACPC consists of following phases:

1. Advertisement of admission process and Online Registration on [www.gujacpc.nic.in](http://www.gujacpc.nic.in)
2. Conduction of PG CET 2020 for Non GATE/GPAT qualified candidates
3. Preparation and declaration of merit & Online Choice filling
4. Admission allotment & confirmation

## INSTRUCTIONS/GUIDELINES FOR ONLINE ADMISSION PROCESS

**All the candidates hereby informed that all the activities of admission process are to be performed within stipulated time limit as declared by Admission Committee, and refer the admission schedule declared by Admission Committee time to time.**

- Candidates who have passed the qualifying examination as per eligibility criteria mentioned in Appendix-I of Education department, Government of Gujarat Notification No.GH/SH/26/2020/PVS/102020/242/S dated 30/06/2020 available on committee's website at link [http://www.jacpcldce.ac.in/Adm20/PG/Noti\\_ME-MPh\\_20200630.pdf](http://www.jacpcldce.ac.in/Adm20/PG/Noti_ME-MPh_20200630.pdf) shall be eligible for registration
- The candidates seeking admission are advised to study the admission rules vide Education department, Government of Gujarat Notification GH/SH/26/2020/PVS/102020/242/S dated 30/06/2020, (available on committee's website). **However in case of a candidate applying without being eligible his registration will be summarily rejected and his registration fee will be forfeited. No correspondence will be entertained in this matter.**
- Both GATE/GPAT qualified candidates and non-GATE/GPAT candidates including Sponsored candidates shall have to apply online to become eligible for admission
- The eligible Candidate should apply to appropriate discipline for which he is eligible as per eligibility criteria shown in Appendix – I of Education department, Government of Gujarat Notification No. GH/SH/26/2020/PVS/102020/242/S dated 30/06/2020.
- **If he is eligible for more than one discipline, he can apply for as many disciplines, provided he has to pay registration fee of Rs. 500/- per discipline, thus if you tick/apply for two disciplines than registration fee shall be Rs. 1000 and thereafter in multiple of Rs. 500.**
- **The registration fee so paid is non-refundable, thus while ticking the name and no. of discipline, one should be extra cautious, as there is no provision of refund in event of ticking the discipline by mistake or an oversight. Also, there is no provision for adding the application of discipline after successful completion of registration process. No correspondence shall be entertained in this matter related to refund of registration fee or addition of any discipline.**
- For online registration, eligible candidates should visit web site [www.gujacpc.nic.in](http://www.gujacpc.nic.in) from anywhere through internet between **08/09/2020 to 16/09/2020**. Please note that, candidate shall not be allowed to register online after 5:00 P.M. on 16/09/2020. Please note that no other means of registration are available.
- The detail steps of registration are available on the committee's website with a link **Steps for Registration** in ME/MTech/Mpharm tab.
- Other information related to admission process such as Important instructions for admission process, Admission rules, PG CET-2020 syllabus and schedule, list of

- institutes, list of Cyber Centre, etc. are available on the website [www.jacpcldce.ac.in](http://www.jacpcldce.ac.in)
- The aspiring candidate not having internet facility can avail the same at Cyber Centres designated by admission committee without paying any charges. (The list is available on committee's website [www.jacpcldce.ac.in](http://www.jacpcldce.ac.in)). The working hours of designated Cyber Centres are from 11:00 am to 5:00 pm except Public Holidays and online admission related help shall be provided free of cost.
  - All Non-GATE/Non-GPAT candidates including sponsored (Non-GATE/Non-GPAT) shall have to appear in PG CET-2020 to become eligible for admission, the applicant has to appear for PG CET-2020 in the discipline he has applied for and if he has applied for more than one discipline he has to appear for the PG CET in as many disciplines as per his application for admission. The detail discipline wise program for PG CET 2020 shall be available immediately after completion of registration process on committee's website [www.jacpcldce.ac.in](http://www.jacpcldce.ac.in)
  - However GATE/GPAT qualified candidates have not to appear in PG CET-2020
  - The candidate shall have to complete the registration process by uploading all relevant documents and paying registration fees (nonrefundable) of INR 500/- per discipline applied for through online mode only.
  - There is no need to submit or verify any document in person. The entire admission process is completely online.
  - The candidates whose result for final semester or in any backlog in previous semester is awaited are also eligible to apply provided they shall have to pass the qualifying examination as mentioned in Appendix-I of Education department, Government of Gujarat Notification No. GH/SH/26/2020/PVS/102020/242/S dated 30/06/2020. However, the merit number in such cases will be allotted, if the mark sheet and provisional degree certificate of passing of qualifying examination is submitted/uploaded within the scheduled time limit.
  - After admitting GATE/GPAT qualified candidates as per merit of the valid GATE/GPAT qualifying marks/score, the vacant seats if any, will be filled as per merit secured in PG CET 2020.
  - The candidates who have passed qualifying examination with a mark sheet having SPI/CPI/CGPA/Grade shall have to produce percentage equivalent certificate issued by university/institute from where they have passed the qualifying examination.
- For GTU candidates, the conversion formula for CGPA to equivalent % is as follows:**

**% Equivalent marks = (CGPA- 0.5) x 10**

- All the GATE/GPAT Qualified candidates shall have to submit/upload copy of GATE/GPAT score card.
- The application of the sponsored candidate shall be submitted by the Institute /authority sponsoring the candidate along with sponsorship letter. The sponsored candidate also shall have to apply online to become eligible for admission. Further they shall have to **upload copy of experience certificates, Form 16 under IT Act,**

**1961 for last 2 years from the employer and sponsorship letter (standard format)** available at the end of in this file in addition to other requisite certificates/documents.

- The caste certificate/Non inclusion in creamy layer certificate for SEBC category/Medical Certificate for Physically Handicapped candidate /Ex-serviceman/In-serviceman category certificate/ Sponsorship certificate/ Economically weaker Section Certificate (EWS) etc should be duly stamped, signed and issued by the authority empowered by Government of Gujarat.
- The candidate belonging to SEBC category shall have to submit/upload certificate to the effect of non-inclusion in Creamy Layer ("**Parishista 4" in Gujarati version only**), the said certificate shall have validity as per prevailing government rules/norm from time to time.
- **Tuition fee waiver (TFW) : The tuition fee waiver is not applicable in ME/MTech/Mpharm courses. This information is asked for the purpose of creation of general profile of candidate only during online registration process, since this profile creation is common and utilised for all courses. The benefit is available only in eligible courses and not for ME/MTech/Mpharm courses. All eligible candidates are hereby informed to take note of this rules/norms related to TFW scheme for ME/MTech/Mpharm courses**
- **The Registration slip cum Hall ticket for PGCET-2020 and a photo identity proof in original must be produced at the time of the PGCET-2020 for verification. No candidate shall be permitted to appear in the PGCET-2020 without the valid registration slip. It must be preserved even after the PGCET-2020 and it should be presented as and when required during the entire admission process.**
- The Examination number for PGCET 2020 is your **Application number** allotted to you by this committee during online registration. If there is change in the examination Number, the same shall be notified on the Admission Committee Website before the PGCET 2020 scheduled date.
- The PGCET-2020 shall be conducted at following centers in the state of Gujarat.
  - (i) L. D. College of Engineering, Ahmedabad
  - (ii) Dr. S. & S.S. Gandhi Government Engineering college, Surat
  - (iii) Government Engineering College, Rajkot
  - (iv) Faculty of technology and Engineering, M. S. University, Vadodara
- The Non-GATE/GPAT candidates are informed to fill their option for the PGCET-2020 examination center in the online registration module and center once selected shall not be changed which may please be noted by the aspiring candidates.
- Incomplete filling of registration forms and or incomplete uploading of documents are liable to be cancellation/rejection of registration and shall not be considered in further admission process.
- No separate call letter shall be issued for appearing in PGCET-2020. The candidate shall have to remain present as per schedule mentioned in admission schedule at

his own cost.

- The admission on Sponsored seats shall be as per Government of Gujarat Post graduate Admission rules, guidelines and AICTE guidelines. The guidelines for admission in Sponsored category is available on committee's website.
- If you possess required experience, sponsorship letter from your sponsorer, Form 16 from Income tax department for last two years based on your employment for last two years, and other related documents, then only fill **YES** for Are you applying as sponsored candidate during online registration process.
- If any of the required documents/information is missing, your application shall not be considered eligible as Sponsored candidate.
- Hence, it is advised to be cautious in clicking YES here, if required documents as stated in rules and as above are not uploaded, your application will be summararily rejected as Sponsored candidate. This may be noted by all aspiring candidates applying for as Sponsored Candidates.
- A combined pdf file comprising of experience certificates, Form 16 under IT Act, 1961 for last 2 years from the employer and sponsorship letter (standard format as shown at the end of this document) from your present employer has to be uploaded in Document upload page as an Sponsored category document
- NOTE: If you are not fulfilling the requirements of Sponsored candidate as per prevailing rules and guidelines (all available on committee's website), then fill NO and proceed further for registration process.
- After successful completion of registration process including successful verification of documents, conductance of PG CET - 2020, provisional merit number (rank) will be allotted to eligible candidates on a stipulated date. Candidate will be able to view provisional merit number (rank) on website [www.gujacpc.nic.in](http://www.gujacpc.nic.in) by login with their User ID and password OR can also view on website [www.jacpcldce.ac.in](http://www.jacpcldce.ac.in). The candidate who have been allotted merit number can start filling their choices related to their Discipline applied for and Course/Specialization based on B.E. passing degree and Discipline applied for within the stipulated schedule as declared by admission committee.
- Candidates who are eligible as per prevailing rules of admission to ME/MTech/MPharam and who have successfully completed registration and verification of documents at the time of declaration of merit shall only be allotted the merit rank. Only those candidates who are allotted merit rank shall be considered for further admission process.
- **Important note for GATE qualified candidates:** It is the responsibility of the admitting institution/university to award the MHRD scholarship/assistantship to only those candidates who have secured marks equal to or more than the “qualifying mark” in the concerned GATE/GPAT discipline and for the corresponding category of the candidate. The management of the postgraduate scholarship/assistantship is also the responsibility of the admitting

institution/university. The admission committee has no role in the award or disbursement of scholarship/assistantship. Thus, mere admission as “GATE/GPAT qualified candidates”, does not guarantee MHRD Scholarship/assistantship.

- The Name of Post Graduate Discipline and Name of course/specialization as mentioned in the Provisional list of institutes is for Admission purpose only, it has no co-relation with the nomenclature of the degree awarded by the Concerned Institute/ University. The Candidate are hereby advised to contact the respective Institute/ University or competent authorities before securing admission, for the exact nomenclature of the degree awarded, its detailed syllabus and employment prospects for different courses / specialization as stated in list of institutes. The Admission committee has no role in the nomenclature of the Degree awarded and their syllabus of the concerned Institute / University.
- In case of GATE/GPAT qualified candidate the candidate shall be eligible as per his category in the respective discipline based on qualifying marks/scores as announced by GATE/GPAT coordinating bodies. A reserved category candidate shall be eligible on unreserved seat provided he is having qualifying score/marks for unreserved category. However, he shall be eligible on reserved seat only, if he is having qualifying marks/score for concerned category and discipline.

**If the information submitted by any candidate is found to be fraudulent, incorrect or untrue at any stage (even after provisional admission), the seat allotted (if any) will be cancelled without any further reference. Moreover, such candidate may no longer be considered eligible for admission and will also be liable for legal/penal actions.**

A candidate shall have passed HSC (10+2) with minimum 45% marks (40% for SC/ST/SEBC/EWS) of theory (or theory and practical) marks of Physics & Mathematics as compulsory subjects with (Chemistry or Biology or Technical Vocational subject) from a single board. Candidate shall also appear in JEE (Main) examination in respective subjects.

**Candidate satisfying both criteria can apply in both section [A] and [B] with single application.**

**Reservation for Admission**

**[A]** For the purpose of admission in Government Seats, the seats shall be reserved under the following categories and in following proportion, namely: -

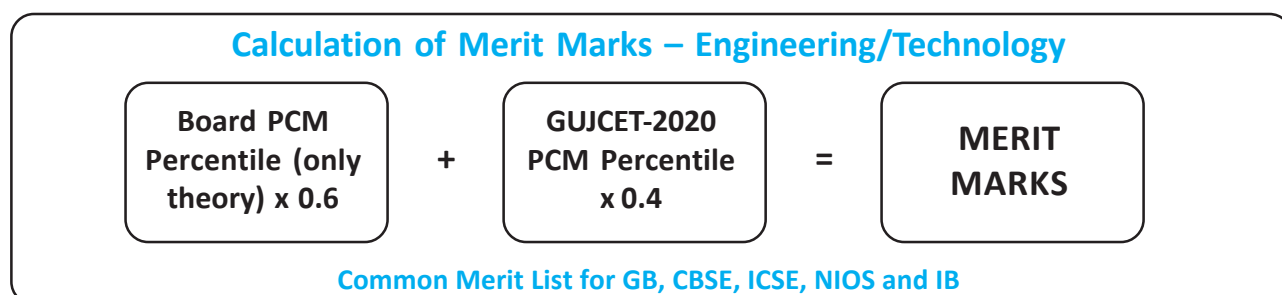
**[B]** For the purpose of admission in Government Seats, the seats shall be reserved under the following as sub-category in each of the available category and in following proportion, namely :-

**Calculation of Merit Marks**

**[A] For Students who have passed qualifying examination from school located in Gujarat and appeared in GUJCET -2020**

60% weightage of the percentile obtained in the theory subjects (PCM) of board exam combined with 40% weightage of the percentile obtained in the GUJCET 2020. A common merit list will be prepared for GSEB, CBSE, ICSE, Cambridge, IB and NIOS board.



**[B] For Students who have passed qualifying examination from school located in India (including Gujarat State) and appeared in JEE(Main) 2020**

Merit list of candidates who have passed the Qualifying Examination from schools located in India (including Gujarat State) from a valid Board as recognised by the Gujarat Board; and appeared in JEE(Main) examination shall be prepared on the basis of All India Rank of JEE (Main) examination for the corresponding year.
