It is resolved that, Dr. Vedvyas J.Dwivedi is selected on the post of Provost for three years as provided under section 15(l) of Gujarat Private University Act,2009. His monthly salary is rupees 2,15,000/- (Fixed) and rupees 15000/- extra for other facilities.

- Item No. 4.7 To grant permission to proposed Gokul Homoeopathic Medical College as the Constituent College of the University.

The Gokul Foundation is the sponsoring body of the University. It has taken decision to start new course of BHMS under the proposed "Gokul Homoeopathic Medical College" from Academic Year 2021-22 having intake capacity of 100 seats vide resolution no.77 dated 19/07/2019. In this regard, a letter has been received from authorized officer Shri R.P.Solanki, Sidhpur dated 02/07/2020 seeking affiliation of proposed college to Gokul Global University.
