In supersession to order vide letter no. 30-5/2022-23/NCH-GR (10)/ 10827 dated 06.12.2022 revised order is issued as under:

"With reference to the above cited subject, and referred letter the undersigned is directed by the competent authority to convey as under:

The college submission as appeal has been carefully examined by the Commission and observations are as under:

1. It is observed that as per sub-regulation (2) of Regulation 9 of MSR 2013 Regulation teachers or consultants of modern medicine are in addition to the teaching faculty.

**Overall observations:**

1. Based on the submission made by Gokul Homeopathy Medical College, Gokul Foundation. Opp. IOC Depot, State Highway No. 41, Sujapur Patia, Dist. Patan, Gujarat-384151 on 18.11.2022, the documents have been carefully examined as per the provisions of the Homoeopathy Central council (minimum Standards Requirement of Homeopathic Colleges and attached Hospitals) regulations, 2013 and the relevant regulations made there under and it is observed that college is fulfilling the requirement of MSR 2013 Regulation.
2. Now, THEREFORE, the Commission has decided to issue Letter of Permission to start new BHMS course with intake capacity of 100 seats for the academic session 2022-23 under section 29 of NCH Act 2020.

3. All admissions in Under Graduate (BHMS) course shall be through 'National Eligibility Entrance Test (NEET)' only. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and will invite penalty as may be decided will be imposed.
4. The counselling for 15% seats under All India quota shall be conducted by respective counselling Authority of State/ UT Government as designated by the Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counselling Authority of that State / UT. 100% Under Graduate seats of the permitted intake capacity shall be treated as all India quota for Deemed University as they are All India in nature. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted shall be informed to the Medical Assessment and Rating Board for Homoeopathy immediately after the process of admission is completed.
5. Accordingly, your representation dated 18.11.2022 to Commission against order of MARBH vide letter dated 12.11.2022 stands disposed off".
