## **PURPOSE:**

The purpose of this MOU is to begin and/or to expand a framework of cooperation between **Gokul Global University**, **Siddhpur** and **Shri N. S. Patel Law College, Modasa** to organise training conducting classes for the competitive exams for graduates and under graduates' holders of the GGU campus students. Various competitive exam related trainings.

WHEREAS, PARTY No II shall be getting all required services from PARTY No I as per this MoU and the addition/deletion in services can be amended from time to time with mutual consent with the terms and conditions stated below-

## 1. Details of Partnering Institution

- 1.1. National / Deemed to be Private: Gokul Global University is a Private University established by the Gujarat Private University act, 2009
- 1.2. Teaching: Gokul Integrated Law College, offers 5 year integrated B.A. LL.B and B.Com. LL.B programmes, LL.M (one year with four specialization), LL.M (Two Year Course) and Ph.D. in Law Degree programs. Along with it we conduct regular faculty development programs on current developments in Law
- 1.3. Research: Faculty of Law regularly conducts and encourages active research on various issues of law. It is also envisioned that the Faculty of Law will open research centres to promote and ruther research culture at Gokul Global University, Sidhpur

## 2. Functions and duties:

- 2.1. To select students trainees and arrange for their placements;
- 2.2. To prepare programmes of training in consultation with the participating training establishments;
- 2.3. To supervise training with the help of training field officers appointed for the purpose;
- 2.4. To award and to disburse stipends to the trainees at the rates to be prescribed for the Purpose.
- 2.5. To award certificates in accordance with the rules to trainees who complete their training.
- 2.6. To arrange guest lectures for students knowledge.

- 2.7. To arrange dissemination of information on various aspects of practical training through documentation of literature, lectures, films and other media of communications;
- 2.8. To provide expert and advisory services in the areas of practical training to both Institutions and Industry.

## 3. Delivery Services

- 3.1. The Party No I agrees that it is its sole responsibility to provide training to all the students of Faculty of Law to enhance their skills and improve their knowledge for competitive exam
- 3.2. The following terms are to be strictly followed and complied by the concerned party:
  - (i) All training sessions shall be carried out by qualified and experienced staff.
  - (ii) All legal formalities to be completed
  - (iii) The reports of training records of all students are to be kept.
  - (iv) Party no I & II shall cooperate in providing past reports in case of requirement.
- 3.3. The Party No I & II agree that the services will be witnessed in the welfare of the students for their training, skill development and placement so the records should be maintained regularly and shared between the parties.
- 3.4. The period of memorandum of understanding shall be mutually decided by both the parties such as for a period of minimum 1 years commencing from the date of execution of this deed.
- 3.5. If parties to this memorandum of understanding intend to terminate the agreement it shall give three month notice in advance in writing to either side without assigning any reasons.
- 3.6. If any dispute arises regarding the non-compliance and/or its interpretation of the terms and conditions of this memorandum of understanding and its implementation the same shall be referred by the aggrieved party to the appropriate court of law at Sidhpur Jurisdiction, whose decision shall be final and conclusive.
- 3.7. Party II have to provide training to all the students enrolling depending upon the courses module.

## 4. Student exchange Programme.

Faculty of Law, Gokul Global University and Shri N. S. Patel Law College, Modasa agree that student exchange will be guided by principles listed below A home institution refers to the institution where a student is a full-time student, and from where he/she is expected to graduate. A host institution refers to an institution that receives a student for a brief period of time to undertake a predetermined programme of study or research.

- **4.1.** Exchange students will be selected by mutual agreement between the home institution and the host institution.
- **4.2.** An exchange student will continue to be treated as full-time student at his/her home institution.
- **4.3.** An exchange student will be considered as full-time "exchange" student at the host institution.
- **4.4.** His/her programme of study at the host institution will be determined by mutual consultation between his/her academic advisor at the home institution and his/her "interim" academic advisor identified by the host institution.
- **4.5.** The host institution will evaluate an exchange student's performance in each course or module, award a letter grade or marks, and issue a letter to that effect.

#### 5. Faculty/Staff Exchanges:

- 5.1. The exchange of faculty to the mutual benefit of both institutions,
- 5.2. Collaboration in teaching, research and development, and consultancy studies in the field of mutual interest,
- 5.3. The exchange of academic materials and publications,
- 5.4. Conducting lectures,
- 5.5. Undertaking joint research,
- 5.6. Attachment of staff for purposes of curriculum development and review, attendance of courses, upgrading of teaching and research skills,
- 5.7. Participating in seminars, symposiums, and other types of academic discussions,
- 5.8. Co-supervising post-graduate students,
- 5.9. Conducting study tours and joint consultancy work

#### 6. Co-curricular activities.

Emphasis is laid on the need to balance in-class and out-of-class life. The students work hard in class, but they will also utilize energy for diverse activities such as organizing seminars on contemporary legal issues, publishing in-house magazines, organizing guest lectures, participating in inter and intra-law college competitions.
